

Religious Violence Today: Faith and Conflict in the Modern World [2 volumes] by Michael Jerryson (2020)

Through sections containing overview essays and reference entries related to particular religions, this resource explores the rise of religious violence, hate crime, and persecution around the world. Religious violence and persecution have been growing steadily both within the United States and around the world. Drawing on the expertise of a wide range of scholars, this current and comprehensive reference helps readers understand the persecution of members of particular faiths as well as violence committed by members of those faiths. In doing so it promotes a greater understanding of the role of religion in global politics, domestic and international terrorism, and religious bigotry. Magico-Religious Groups and Ritualistic Activities: A Guide for First Responders by Tony Kail (2008)

A woman lays unconscious on the floor surrounded by charcoaled symbols, burning candles, a bowl of viscous red liquid, and an array of dried herbs. Was this a healing ritual gone wrong or just straightforward foul play? Increasingly, first responders must deal with foreign practices and cultures that are often disturbing in their unfamiliarity. Understanding cultural variations and nuances can make the difference between muchneeded emergency treatment and the aggravation of an already sensitive situation. The first book of its kind, provides a cultural bridge for emergency personnel when interacting with various magico-religious cultures. More than just a litany of artifacts, rituals, and symbols, this valuable book draws from cultural anthropology and religious studies to unearth hidden meanings and place the information in a context relevant for the first responder. It offers crucial keys for improving communication, assessment, and treatment in culturally sensitive situations. Beginning with an introduction to the importance of trans-cultural communication, the book devotes subsequent chapters to the common and contrasting elements of several magico-religious groups. It considers the practices of Neo-Paganism, Santeria, Bantu religion (Palo Mayombe), Voodoo, and Curanderismo. The book separates fact from fantasy regarding sacred spaces and dates, ceremonies, group structure, sacred objects, cultural taboos, and beliefs about sickness and healing. It also includes a detailed review of the common herbs used in healing and ritual, as well as a glossary of cultural terms and an index of symbols. Promoting functional cultural competency, this book gives public service agencies and emergency responders the tools to properly assess situations, open lines of communication, protect cultural diversity and beliefs and, above all, provide effective emergency treatment.

On Pilgrimage: Sacred Journeys Around the World by Jennifer Westwood (2002) On Pilgrimage walks readers through the 12 stages that are common to sacred journeys, describing both the spiritual and physical process. It features over 60

pilgrimage destinations worldwide and emphasizes both the personal quest and the multicultural and multifaith dimension of sacred travel.



RELIGION & FOREIGN POLICY

Finding Faith in Foreign Policy: Religion and American Diplomacy in a Postsecular World by Gregorio Bettiza (2019) Simply put, religion has become a major subject and object of American foreign policy in ways that were unimaginable just a few decades ago. This book explains the causes and consequences of this shift by developing an

original theoretical framework and drawing upon extensive empirical research and interviews. He argues that American foreign policy and religious forces have become ever more inextricably entangled in an age witnessing a global resurgence of religion and the emergence of a post-secular world society. He further shows how the boundaries between faith and state have been redefined through processes of de-secularization in the context of American foreign policy, leading the most powerful state in the international system to intervene and reshape in increasingly sustained ways sacred and secular landscapes around the globe.

Religion and Authoritarianism: Cooperation, Conflict, and the Consequences (Cambridge Studies in Social Theory, Religion and Politics) (2014)

This book provides a rare window into the micro-politics of contemporary authoritarian rule through a comparison of religious-state relations in Russia and China - two countries with long histories of religious repression, and even longer experiences with authoritarian politics. Drawing on extensive fieldwork in multiple sites in these countries, this book explores what religious and political authority want from one another, how they negotiate the terms of their relationship, and how cooperative or conflicting their interactions are. This comparison reveals that while tensions exist between the two sides, there is also ample room for mutually beneficial interaction. Religious communities and their authoritarian overseers are cooperating around the core issue of politics - namely, the struggle for money, power and prestige - and becoming unexpected allies in the process.

Religion on the Battlefield by Ron Hassner (2016)

Focuses on the everyday practice of religion in a military context: the prayers, rituals, fasts, and feasts of the religious practitioners who make up the bulk of the adversaries in, bystanders to, and observers of armed conflicts. To show that religious practices

have influenced battlefield decision making, Hassner draws most of his examples from major wars involving Western militaries. They include British soldiers in the trenches of World War I, U.S. pilots in World War II, and U.S. Marines in Iraq and Afghanistan. Hassner shows that even modern, rational, and bureaucratized military organizations have taken—and must take—religious practice into account in the conduct of war.



Rethinking Religion and World Affairs by Timothy Samuel Shah (Editor), Alfred Stepan (Editor), Monica Duffy Toft (Editor) (2012) In recent years, the role of religion in the study and conduct of international affairs has become increasingly important. The essays in this volume seek to question and remedy the problematic neglect of religion in extant scholarship, grappling with puzzles, issues, and questions concerning religion and world affairs in six major

areas. Contributors critically revisit the "secularization thesis," which proclaimed the steady erosion of religion's public presence as an effect of modernization; explore the relationship between religion, democracy, and the juridico-political discourse of human rights; assess the role of religion in fomenting, ameliorating, and redressing violent conflict; and consider the value of religious beliefs, actors, and institutions to the delivery of humanitarian aid and the fostering of socio-economic development. Finally, the volume addresses the representation of religion in the expanding global media landscape, the unique place of religion in American foreign policy, and the dilemmas it presents. Drawing on the work of leading scholars as well as policy makers and analysts, Rethinking Religion and World Affairs is the first comprehensive and authoritative guide to the interconnections of religion and global politics.

Religion and Foreign Affairs by Dennis Hoover and Douglas Johnston (2012) Offers readers a broad selection of essays, ranging across cultures and worldviews. From the ethics of force and peacemaking to globalization and American foreign policy, this compendium provides a solid introduction to the field of religion and foreign affairs that will stimulate discussion and encourage intelligent practice.

Religion, Terror, and Error: U.S. Foreign Policy and the Challenge of Spiritual Engagement by Douglas M. Johnston (2011)

It shows how the United States can reposition itself to deal more effectively with the causal factors that underlie religious extremism; offers a successor to the rational-actor

model of decision-making that has heretofore excluded "irrational" factors like religion; and suggests a new paradigm for U.S. leadership in anticipation of tomorrow's multipolar world. Describing how the United States should realign itself to deal more effectively with the factors underlying religious extremism, this innovative treatise explains how existing capabilities can be redirected to respond to the challenge and identifies additional capabilities that will be needed to complete the task.

The Global Resurgence of Religion and the Transformation of International Relations: The Struggle for the Soul of the Twenty-First Century by Scott Thomas (2005)

This book is about the global resurgence of culture and religion in international relations, and how these social changes are transforming our understanding of International Relation theory, and the key policy-related issue areas in world politics. It is evident in the on-going debates over the 'root causes' of 9/11 that there are many scholars, journalists and members of the public who still believe culture and religion can be explained away by appeals to more 'basic' economic, social or political forces in society. Therefore The Global Resurgence of Religion and the Transformation of International Relations presents an argument for taking culture - and particularly religion - as social forces that are important for understanding world politics in the post-Westphalian era.

Religion, The Missing Dimension of Statecraft by Douglas Johnston (editor) (1994) The particularly American tendency to separate political from spiritual life often tends to ignore a vital aspect of international relations--one that can be a powerful tool in negotiations. Religion plays a crucial role in many international conflicts, yet for the most part, diplomacy either ignores or misunderstands its role. This unified collection of case studies and theoretical pieces attempts to restore this missing dimension to its rightful place in the conduct of international diplomacy.

Out of Many Faiths: Religious Diversity and the American Promise by Eboo Patel (2019) America is the most religiously diverse nation on the planet. In today's volatile climate of religious conflict and distrust, how do we affirm that the American promise is deeply intertwined with how each of us engages with people of different beliefs? Patel draws on his personal experience as a Muslim in America to examine

the importance of religious diversity in the nation's cultural, political, and economic life. He explores how religious language has given the United States some of its most

enduring symbols and inspired its most vital civic institutions—and demonstrates how the genius of the American experiment lies in its empowerment of all people.

Narco-Cults by Tony Kail (2015)

Those who know about how spirituality plays into the world of drug smuggling have likely heard of Santa Muerte, Jesus Malverde, and Santería, but the details of the more obscure African religions and Latin American folk saints and cults often remain a mystery. While the vast majority of these religions are practiced by law-abiding citizens with no connections to the drug trade, their religious beliefs and practices are often appropriated by drug cartels and used to psychologically empower members of these organizations. Therefore, knowledge about narco-cults and spirituality related to the drug trade can be incredibly useful to narcotics officers, military and intelligence agents, and even the average street cop. This book looks at the growing phenomenon of narco-cults and the use of indigenous spiritual traditions among drug trafficking organizations. Based on two decades of experience from one of the top consultants in the field, it provides investigative agencies with a means of identifying symbols, rituals, artifacts, and customs endemic to various drug trafficking organizations. The book features illustrations of altars, shrines, and tools along with detailed descriptions of their cultural significance and practical application in rituals and customs.

Derived from empirical research, this sourcebook provides reliable information taken from ethnographic fieldwork, police reports, and interviews with practitioners. The knowledge contained herein will help build cultural competency among the many agencies investigating drug crimes.

Saving Faith: Making Religious Pluralism an American Value at the Dawn of the Secular Age by David Mislin (2015)

Chronicles the transformative historical moment when Americans began to reimagine their nation as one strengthened by the diverse faiths of its peoples. Between 1875 and

1925, liberal Protestant leaders abandoned religious exclusivism and leveraged their considerable cultural influence to push others to do the same. This reorientation came about as an ever-growing group of Americans found their religious faith under attack on social, intellectual, and political fronts. A new generation of outspoken agnostics assailed the very foundation of belief, while noted intellectuals embraced novel spiritual practices and claimed that Protestant Christianity had outlived its usefulness. Faced with these grave challenges, Protestant clergy and their allies realized that the successful defense of religion against secularism required a



defense of *all* religious traditions. They affirmed the social value—and ultimately the religious truth—of Catholicism, Judaism, Hinduism, Buddhism, and Islam. They also came to view doubt and uncertainty as expressions of faith.

Horizons of the Sacred: Mexican Traditions in U.S. Catholicism by Timothy Matovina & Gary Riebe-Estrella (2002)

Explores the distinctive worldview underlying the faith and lived religion of Catholics of Mexican descent living in the United States. Religious practices, including devotion to Our Lady of Guadalupe, celebration of the Day of the Dead, the healing tradition of curanderismo, and Good Friday devotions such as the Way of the Cross (Via Crucis), reflect the increasing influence of Mexican traditions in U.S. Catholicism, especially since Mexicans and Mexican Americans are a growing group in most Roman Catholic congregations.

Following the Great Spirit: Exploring Aboriginal Belief Systems by Michael Davie (2015)

In crisis situations, aboriginal peoples in North America and elsewhere in the world have turned belief systems and values for spiritual guidance to help them cope with great change. Following The Great Spirit examines the ways in which these peoples have looked to their tribe's 'Great Spirit' to come to terms with turmoil and disruption in their societies. Author Michael B. Davie explores the Ghost Dance practiced by natives in the United States and Canada to overcome the onslaught of change brought about by European settlement. Also explored are the supposedly bullet-proof Ghost Shirt; the rise and fall of native influence in the fur trade and the Gisara ceremony in which dancers are literally burned by their audience - an insightful look at belief systems that guide and shape whole societies.

Native Religions and Cultures of North America: Anthropology of the Sacred by Lawrence Sullivan (2003)

This volume contains insightful essays on significant spiritual moments in eight different Native American cultures: Absaroke/Crow, Creek/Muskogee, Lakota, Mescalero, Apache, Navajo, Tlingit, Yup'ik, and Yurok.

Church, Cosmovision and the Environment: Religion and Social Conflict in Contemporary Latin America by Evan Berry (2018)

Firstly, it provides comparative analysis of the manner in which diverse religious actors are currently participating in transnational, national, and local advocacy in places such as, Peru, Argentina, Brazil, Bolivia, Ecuador, Guatemala, and Mexico. It also considers the diversity of an often plural religious engagement with advocacy, including Catholic, Evangelical and Pentecostal perspectives alongside the effects of indigenous cosmological ideas. Finally, this book explores the specific religious sources of seemingly unlikely new alliances and novel articulations of rights, social justice, and ethics for the environmental concerns of Latin America.

The Cambridge History of Religions in Latin America by Garrard-Burnett, Virginia, Paul Freston, and Stephen C. Dove (2016)

This comprehensive volume covers Latin American religious history from pre-Conquest times until the present. It addresses such varied religious traditions as indigenous spiritual religions, non-Christian traditions, new religious movements, and religions of the African diaspora. Furthermore, it describes the process of religious change that Latin America is currently undergoing.

Religious Responses to Violence: Human Rights in Latin America Past and Present edited by Alexander Wilde (2015)

During the past half century, Latin America has evolved from a region of political instability and frequent dictatorships into one of elected governments. Although its societies and economies have undergone sweeping changes, high levels of violence have remained a persistent problem. Religious Responses to Violence: Human Rights in Latin America Past and Present offers rich resources to understand how religion has perceived and addressed different forms of violence, from the political and state violence of the 1970s and 1980s to the drug traffickers and youth gangs of today. The contributors offer many fresh insights into contemporary criminal violence and reconsider past interpretations of political violence, liberation theology, and human rights in light of new questions and evidence. In contrast to many other studies of violence, this book explores its moral dimensions—up close in lived experience—and the real consequences of human agency. Alexander Wilde provides a thoughtful substantive introduction, followed by thematic chapters on "rights," "violence," and case studies of ten countries throughout the region. The book breaks new ground examining common responses as well as differences between Catholic and Evangelical pastoral accompaniment. These new studies focus on the specifically religious character of their responses—how they relate their mission and faith to violence in different contexts—to better understand how and why they have taken action.



Rethinking insurgency: criminality, spirituality, and societal warfare in the Americas by John P. Sullivan & Robert J. Bunker (2011) Driven by globalization, Internet communications technology (ICT), and new economic forms the nature of states may be changing. Transnational criminal organizations (TCOs) -

including what are commonly known as cartels – are early adopters to the new political/economic landscape. In addition to seeking to rule the illicit economy, criminal actors (networked cartels and gangs) are challenging states through high-order violence and leveraging nascent social/spiritual movements (*narcocultura*) to potentially usher in a new political dynamic. These violent non-state actors (criminal soldiers) are insurgent actors. They are waging new forms of insurgency – criminal and possibly spiritual – that have the potential to reconfigure states.

The True Significance of Sacred Tradition and Its Great Worth by St. Raphael Hawaweeny (Author), Patrick Viscuso (Translator) (2017)

Never before published, the theological thesis of St. Raphael Hawaweeny (1860–1915) is a fascinating work that shows the intersection of Roman Catholicism, Protestantism, and Eastern Orthodoxy in the late nineteenth century. Canonized by the Orthodox Church in 2000, St. Raphael was the first Orthodox bishop consecrated in the western hemisphere. His thesis reflects the life of the Orthodox community under Ottoman rule and is an apologia for Orthodox tradition, acting as a response to arguments advanced by Roman Catholic and Protestant missionaries in the Middle East. Patrick Viscuso's introduction explains the complex historical and theological forces at work in St. Raphael's world. Since the sixteenth century, the Roman Catholic Church had launched major proselytization efforts toward Orthodox Christians in the Ottoman Empire, with the support of the great Western powers. In the late nineteenth century, the United States dominated Protestant efforts in the region. The powerful language in St. Raphael's thesis and his refutation of Roman Catholic and Protestant positions reflect an active dialogue with Western Christianity.

The New Sectarianism: The Arab Uprisings and the Rebirth of the Shi'a-Sunni Divide by Geneive Abdo (2016)

The Shi'a-Sunni conflict is one of the most significant outcomes arising from the Arab rebellions. Yet, there is little understanding of who is driving this tension and the underlying causes. By delving deeply into the historical factors leading up to the present-day conflict, *The New Sectarianism* sheds new light on how Shi'a and Sunni perceive one another after the Arab uprisings, how these perceptions have affected the Arab world, and why the dream of a pan-Islamic awakening was misplaced.

Islam in the World Today: A Handbook of Politics, Religion, Culture, and Society by Werner Ende & Udo Steinbach (2010)

Considered the most authoritative single-volume reference work on Islam in the contemporary world, the German-language Der Islam in der Gegenwart, currently in its fifth edition, offers a wealth of authoritative information on the religious, political, social, and cultural life of Islamic nations and of Islamic immigrant communities elsewhere. More current than the latest German edition on which it is based, Islam in the World Today covers a comprehensive array of topics in concise essays by some of the world's leading experts on Islam.

Religion, Conflict, and Military Intervention by Rosemary Durward and Lee Marsden (2009)

The book uniquely combines chapters highlighting Christian and Islamist theological approaches to understanding and interpreting conflict, as well as case studies on the role of religion in US foreign policy and the Iraq war, with religious perspectives on building peace once conflicts are resolved. The volume provides an ideal starting point for anyone wishing to gain a deeper understanding of the religious character of conflict in the twenty-first century and how such conflict could be resolved.

Religion in War and Peace in Africa by Margee Ensign (Editor), Jean-Pierre Karegeye (2020)

This work shows how "Religious extremism" transcends the realm of belief, analyzing current armed conflicts in Africa with perpetrators claiming to act in accord with their religion and moral values.

Religion and Human Security in Africa by Ezra Chitando & Joram Tarusarira (2019) Written by an international team of contributors, this book looks in detail at the intersection of religion and security in a variety of African contexts. Case studies from a diverse set of countries including Nigeria, Ghana, South Africa, Burkina Faso, and more, are used to illustrate wider trends across the continent. Acknowledging that religion can be used to incite violence as well as encourage peace, the chapters employ an interdisciplinary exploration of the ethics, sociology, and politics around these issues.

Contemporary Perspectives on Religions in Africa and the African Diaspora by Carolyn Jones Medine (2015)

The contributors note the historic, philosophical, socio-cultural, moral, and legal implications of religions rooted in African realities and their rich and varied groundings in the diaspora. This book will be a valuable tool for many, especially students of the new

African diaspora who have to welcome and appreciate learning and 'singing [the divine message and song] in a strange land.



African Religions: A Very Short Introduction by Jacob Olupona (2014)What are African religions? This work answers this question by examining primarily indigenous religious traditions on the African continent, as well as exploring

Christianity and Islam. It focuses on the diversity of ethnic groups, languages, cultures, and worldviews, emphasizing the continent's regional diversity.

African Religions: Symbol, Ritual, and Community by Benjamin Ray (1999)

This book presents a portrait of African religious history framed in the religious themes common to the rest of the world. It looks at the traditional religions that provided the philosophical, religious, and ethical basis of African culture. Focusing primarily on traditional African religions and their related myths, rituals, authorities, ethics, and artwork, the book also includes substantial treatment on nationalism, African Islam and Christianity. For anyone who wants to gain an understanding of the relationship between African religion and culture.

Great Pilgrimage Sites of Europe by Derry Brabbs (2020)

Pilgrimage in Europe is currently thriving on a scale that simply could not have been envisaged just a few decades ago. Not only are greater numbers of people now emulating the medieval pilgrims who made their way on foot across Europe to the shrines of martyred apostles in Rome (Peter and Paul) and Santiago de Compostela (James), but millions each year are also travelling by air, rail, road and foot to the world famous sites of Marian Apparition such as Lourdes (France), Fatima (Portugal), Knock (Ireland). These three sites alone receive almost 12 million pilgrims a year between them. This book covers all the key pilgrimage sites across Europe, as well the lesser known ones such as La Salette in the French Alps.

Russian Nuclear Orthodoxy: Religion, Politics, and Strategy by Dmitry Adamsky (2019)

A nuclear priesthood has arisen in Russia. From portable churches to the consecration of weapons systems, the Russian Orthodox Church has been integrated into every facet of the armed forces to become a vital part of Russian national security, politics, and identity. This extraordinary intertwining of church and military is nowhere more visible than in the nuclear weapons community, where the priesthood has penetrated all levels of command and the Church has positioned itself as a guardian of the state's nuclear potential. Russian Nuclear Orthodoxy considers how, since the Soviet collapse in 1991, the Church has worked its way into the nuclear forces, the most significant wing of one of the world's most powerful military organizations. Dmitry Adamsky describes how the Orthodox faith has merged with Russian national identity as the Church continues to expand its influence on foreign and domestic politics. The Church both legitimizes and influences Moscow's assertive national security strategy in the twenty-first century. This book sheds light on the role of faith in modern militaries and highlights the implications of this phenomenon for international security. Ultimately, Russian Nuclear Orthodoxy interrogates the implications of the confluence of religion and security for other members of the nuclear club, beyond Russia.

A Sacred Space Is Never Empty: A history of Soviet Atheism by Victoria Smolkin (2019)

Drawing on a wealth of archival material and in-depth interviews with those who were on the front lines of Communist ideological campaigns, Victoria Smolkin argues that to understand the Soviet experiment, we must make sense of Soviet atheism. Smolkin shows how atheism was reimagined as an alternative cosmology with its own set of positive beliefs, practices, and spiritual commitments. Through its engagements with religion, the Soviet leadership realized that removing religion from the "sacred spaces" of Soviet life was not enough. Then, in the final years of the Soviet experiment, Mikhail Gorbachev—in a stunning and unexpected reversal—abandoned atheism and

reintroduced religion into Soviet public life.



Religion During the Russian Ukrainian Conflict by Elizabeth A. Clark & Dmytro Vovk (2019)

This book investigates how the military conflict between Russia and Ukraine has affected the religious situation in these countries. It considers threats to and violations of religious freedom, including those arising in annexed Crimea and in the eastern part of Ukraine, where fighting between Ukrainian government forces and separatist paramilitary groups backed and controlled by Russia is still going on, as well as in Russia and Ukraine more generally. It also

assesses the impact of the conflict on church-state relations and national religion policy in each country and explores the role religion has played in the military conflict and the

ideology surrounding it, focusing especially on the role of the Ukrainian and Russian Orthodox churches, as well as on the consequences for inter-church relations and dialogue.

Russian Orthodoxy Resurgent: Faith and Power in the New Russia by John Garrard (2014)

Explores the expansive and ill-understood role that Russia's ancient Christian faith has played in the fall of Soviet Communism and in the rise of Russian nationalism today. John and Carol Garrard tell the story of how the Orthodox Church's moral weight helped defeat the 1991 coup against Gorbachev launched by Communist Party hardliners. The Soviet Union disintegrated, leaving Russians searching for a usable past. The Garrards reveal how Patriarch Aleksy II--a former KGB officer and the man behind the church's successful defeat of the coup--is reconstituting a new national idea in the church's own image.

New Multicultural Identities in Europe: Religion and Ethnicity in Secular Societies by Erkan Toğuşlu, Johan Leman, İsmail Mesut Sezgin (2014)

How to understand Europe's post-migrant Islam on the one hand and indigenous, anti-Islamic movements on the other? What impact will religion have on the European secular world and its regulation? How do social and economic transitions on a transnational scale challenge ethnic and religious identifications?

These questions are at the very heart of the debate on multiculturalism in present-day Europe and are addressed by the authors in this book. Through the lens of post-migrant societies, manifestations of identity appear in pluralized, fragmented, and deterritorialized forms. This new European multiculturalism calls into question the nature of boundaries between various ethnic-religious groups, as well as the demarcation lines within ethnic-religious communities. Although the contributions in this volume focus on Islam, ample attention is also paid to Christianity, Judaism, and Hinduism. The authors present empirical data from cases in Turkey, Germany, France, Spain, the United Kingdom, Poland, Norway, Sweden, and Belgium, and sharpen the perspectives on the religious-ethnic manifestations of identity in the transnational context of 21st-century Europe.

Defending the Border: Identity, Religion, and Modernity in the Republic of Georgia by Mathijs Pelkmans (2006)

This book, one of the first in English about everyday life in the Republic of Georgia, describes how people construct identity in a rapidly changing border region. Based on extensive ethnographic research, it illuminates the myriad ways residents of the Caucasus have rethought who they are since the collapse of the Soviet Union. Through an exploration of three towns in the southwest corner of Georgia, all of which are situated close to the Turkish frontier, Mathijs Pelkmans shows how social and cultural boundaries took on greater importance in the years of transition, when such divisions were expected to vanish. By tracing the fears, longings, and disillusionment that border dwellers projected on the Iron Curtain, Pelkmans demonstrates how elements of culture formed along and in response to territorial divisions, and how these elements became crucial in attempts to rethink the border after its physical rigidities dissolved in the 1990s.

Shamanism: An A-Z Reference Guide by Marilyn Walker (2020)

Shamanism is a widely used term for a broad range of spiritual practices across time, continents, and cultures. *Shamanism* is your all-in-one reference guide to shamanic traditions and healing modalities around the world.

Improvisational Islam: Indonesian Youth in a Time of Possibility by Nur Amali Ibrahim (2018)

These experimental forms of religious improvisations and practices have developed in a specific Indonesian political context that has evolved after the deposal of President Suharto's authoritarian New Order regime in 1998. At the same time, *Improvisational Islam* suggests that the Indonesian case study brings into sharper relief processes that are happening in ordinary Muslim life everywhere. To be a practitioner of their religion, Muslims draw on and are inspired by not only their holy scriptures, but also the non-traditional ideas and practices that circulate in their society, which importantly include those originating in the West. In the contemporary political discourse where Muslims are

often portrayed as uncompromising and adversarial to the West and where bans and walls are deemed necessary to keep them out, this story about flexible and creative Muslims is an important one to tell.

Zen Baggage by Bill Porter (2018)

In the spring of 2006, Bill Porter traveled through the heart of China, from Beijing to Hong Kong, on a pilgrimage to sites associated with the first six patriarchs of Zen. Zen Baggage is an account of that journey. He weaves together historical background, interviews with Zen masters, and translations of the earliest known records of Zen, along with personal vignettes. Porter's account captures the transformations taking place at religious centers in China but also the abiding legacy they have somehow managed to preserve. Porter brings wisdom and humor to every situation, whether visiting ancient caves containing the most complete collection of Buddhist texts ever uncovered, enduring a six-hour Buddhist ceremony, searching in vain for the ghost in his room, waking up the monk in charge of martial arts at Shaolin Temple, or meeting the abbess of China's first Zen nunnery.

Battling the Buddha of Love: A Cultural Biography of the Greatest Statue Never Built by Jessica Marie Falcone (2018)

Falcone sheds light on the aspirations, values, and practices of both the Buddhists who worked to construct the statue, as well as the Indian farmer-activists who tirelessly protested against the Maitreya Project. Because the majority of the supporters of the Maitreya Project statue are converts to Tibetan Buddhism, individuals Falcone terms "non-heritage" practitioners, she focuses on the spectacular collision of cultural values between small agriculturalists in rural India and transnational Buddhists hailing from Portland to Pretoria. She asks how could a transnational Buddhist organization committed to compassionate practice blithely create so much suffering for impoverished rural Indians. Falcone depicts the cultural logics at work on both sides of the controversy, and through her examination of these logics she reveals the divergent, competing visions of Kushinagar's potential futures. *Battling the Buddha of Love* traces power, faith, and hope through the axes of globalization, transnational religion, and rural grassroots activism in South Asia, showing the unintended local consequences of an international spiritual development project.

The Souls of China: The Return of Religion after Mao by Ian Johnson (2017) China is in the midst of one of the world's great spiritual awakenings: some 300 million Chinese currently practice a faith, while tens of millions more follow personal gurus, populist masters and New Age sages. This astonishing revival began in 1982 when the Communist Party pledged to allow what it thought would be a small-scale practice of religion under government supervision. But the faithful have expanded far beyond the Party's expectations: Today, China's cities and villages are filled with new temples, churches, and mosques as well as cults, sects and politicians trying to harness religion for their own ends. Fueling this resurgence is a popular desire to rediscover a moral compass in a society driven by naked capitalism. For six years, Pulitzer Prize-winning writer Ian Johnson lived for extended periods with three religious communities: the

underground Early Rain Protestant congregation in Chengdu, the Ni family's Buddhist pilgrimage association in Beijing, and yin yang Daoist priests in rural Shanxi. Johnson distills these experiences into a cycle of festivals, births, deaths, detentions, and struggle that reveals the hearts and minds of the Chinese people--a great awakening of faith that is shaping the soul of the world's newest superpower.



The Silk Roads: A New History of the World (2017)

This work realigns our understanding of the world, pointing us eastward. Religion and Development in the Asia-Pacific: Sacred Places as Development Spaces by Anna Halafoff and Matthew Clarke (2016)

Calls for greater attention to be given to the role of sacred places as sites for development activities, and for a deeper appreciation of the way in which sacred stories and teachings inspire people to work for the benefit of others in particular locations. The book considers theories of 'place' as a component of successful development interventions and expands this analysis to consider the specific role that sacred places – buildings and social networks – have in planning, implementing and promoting sustainable development. A series of case studies examine various sacred places as sites for development activities. These case studies include Christian churches and disaster relief in Vanuatu; Muslim shrines and welfare provision in Pakistan; a women's Buddhist monastery in Thailand advancing gender equity; a Jewish aid organization providing language training to Muslim Women in Australia; and Hawaiian sacred sites located within a holistic retreat center committed to ecological sustainability.

The Spirit of Things: Materiality and Religious Diversity in Southeast Asia by Julius Bautista (2012)

What role do objects play in crafting the religions of Southeast Asia and shaping the experiences of believers? *The Spirit of Things* explores religious materiality in a region marked by shifting boundaries, multiple beliefs, and trends toward religious exclusivism.

While most studies of religion in Southeast Asia focus on doctrines or governmental policy, contributors to this volume recognize that religious "things"—statues, talismans, garments, even sacred automobiles—are crucial to worship, and that they have a broad impact on social cohesion. By engaging with religion in its tangible forms, faith communities reiterate their essential narratives, allegiances, and boundaries, and negotiate their coexistence with competing belief systems. These ethnographic and historical studies of Southeast Asia furnish us with intriguing perspectives on wider debates concerning the challenges of secularization, pluralism, and interfaith interactions around the world. In this volume, contributors offer rich ethnographic analyses of religious practices in the Philippines, Thailand, Malaysia, Vietnam, Indonesia, and Burma that examine the roles materiality plays in the religious lives of Southeast Asians. These essays demonstrate that religious materials are embedded in a host of practices that enable the faithful to negotiate the often tumultuous experience of living amid other believers. What we see is that the call for plurality, often initiated by government, increases the importance of religious objects, as they are the means by which the distinctiveness of a particular faith is "fenced" in a field of competing religious discourses. This project is called "the spirit of things" to evoke both the "aura" of religious objects and the power of material things to manifest "that which is fundamental" about faith and belief.

The Religious Question of Modern China by Vincent Goossaert and David Palmer (2011)

Vincent Goossaert and David A. Palmer piece together the puzzle of religion in China not by looking separately at different religions in different contexts, but by writing a unified story of how religion has shaped, and in turn been shaped by, modern Chinese society. From Chinese medicine and the martial arts to communal temple cults and revivalist redemptive societies, the authors demonstrate that from the nineteenth century onward, as the Chinese state shifted, the religious landscape consistently resurfaced in a bewildering variety of old and new forms. The Religious Question in Modern China integrates historical, anthropological, and sociological perspectives in a comprehensive overview of China's religious history that is certain to become an indispensable reference for specialists and students alike.

Qigong Fever by David Palmer (2007)

The practice was promoted by senior Communist Party leaders as a uniquely Chinese healing tradition and as a harbinger of a new scientific revolution, yet the movement's mass popularity and the almost religious devotion of its followers led to its ruthless suppression. In this absorbing and revealing book, David A. Palmer relies on a combination of historical, anthropological, and sociological perspectives to describe the spread of the qigong craze and its reflection of key trends that have shaped China since 1949, including the search for a national identity and an emphasis on the absolute authority of science. Qigong offered the promise of an all-powerful technology of the body rooted in the mysteries of Chinese culture. However, after 1995 the scientific underpinnings of qigong came under attack, its leaders were denounced as charlatans, and its networks of followers, notably Falun gong, were suppressed as "evil cults."

Spirited Politics: Religion and Public Life in Contemporary Southeast Asia by Andrew Clinton Willford, Kenneth M. George (2005)

The essays in *Spirited Politics* throw light on predicaments that spring from the intersection of religion, ethnicity, and nationalism in contemporary Southeast Asian public life. Covering material from Indonesia, Malaysia, Thailand, and the Philippines, the contributors explore the calamities and ironies of Southeast Asian identity politics, examining the ways in which religion and politics are made to serve each other.

Buddha's Warriors: The Story of the CIA-Backed Tibetan Freedom Fighters, the Chinese Communist Invasion, and the Ultimate Fall of Tibet by Mikel Dunham & The Dalai Lama (2004)

Brings to life Tibet before the Chinese communist invasions and depicts the transition of peaceful monks to warriors with the help of the CIA. Tibet in the last sixty years has been so much mystified and politicized that the world at large is confused about what really happened to the "Rooftop of the World" when Mao invaded its borders in 1950.
