I. Preliminaries			
A. Review DoDI 1300.06 and MILPERSMAN 1900-020 on separations based on conscientious objection.			
B. Notify Applicant that the interview is not confidential or privileged and will be used in an official report to advise the command as it prepares a decision/recommendation regarding the Applicant's request.			
C. Obtain Applicant's signed waiver (see attached).			
D. Explain to Applicant that confidential support can be obtained through either: (1) another chaplain or (2) a separate counseling session with the Applicant.			
II. Applicant's Position on War			
A. Is the Applicant against <b>all types</b> of wars, including wars of self-defense and wars with a benevolent purpose (such as ending slavery, preventing genocide, freeing the oppressed)?			
B. Is the Applicant against all wars as opposed to a specific war, including a war the United States may currently be fighting?

C. Timing. Did the Applicant adopt his/her position toward war since joining the Navy, or has he/she held it all along? If he/she has held it all along, why did he/she join the Navy? If he/she adopted it since joining the Navy, how much time elapsed between taking the oath and applying for conscientious objector status?			
D. Is the Applicant's claim of conscientious objection related to membership in a church or religious organization? If so, what are the teachings of the church or religious organization with regard to war and military service?
